2019 FRS-NJ Submission Phase Has Closed

June 30th has passed and thus the 2019 Future Ready Schools - New Jersey submission phase has officially closed!

A record 197 schools from 62 districts submitted for the initial Bronze Tier school certification. Congratulations to all of your teams for joining the FRS-NJ community and starting your Future Ready journey!

Another 62 schools from 21 districts submitted for the second level Silver Tier school certification. Congratulations to all of your teams for learning from your Bronze Tier self-assessment experience and taking the next step!

The first cohort of Silver District Distinction submissions includes all four eligible school districts representing 33 Silver Tier certified schools. Congratulations to Northern Valley Regional High School District, Middletown Township Public Schools, Howell Township Public Schools, and Morris Plains School District!

This issue of the FRS-NJ Monthly issue is dedicated to what happens next now that the submission phase of the 2019 certification cycle has closed. Whether your school submitted for a 2019 certification, or your school intends to start the journey towards 2020 certification, the articles in this newsletter issue are designed to provide you with insight on what to expect in the waning months of the 2019 FRS-NJ certification cycle.

As an important note, as the project coordinator and sole full-time team member of Future Ready Schools - New Jersey, I will be on vacation starting July 4th and returning on Monday July 15th. For the last two years the NJDOE's Commissioner of Education has joined NJSBA's Executive Director Dr. Lawrence Feinsod and representatives from the New Jersey Institute of Technology to recognize the accomplishments of each year's cohort of certified schools. We invite you to join us in celebrating the accomplishments of school and district Future Ready teams who achieve 2019 school certification and, even more prestigiously, those districts that are awarded the new Silver District Distinction!


Schools and districts that submitted for 2019 certification will know their status by September 15th in order to provide enough time to handle logistics and planning for district representative and team attendance at the ceremony.

FRS-NJ will also have a presence on the exhibit floor of the conference next to the main stage in the form of the FRS-NJ Center. The center will house a number of professional development sessions conducted by our

Did Your School Submit This Year? Here's What to Expect Next

If you're reading this article, it is likely that you are one of over 260 schools that submitted for a 2019 Future Ready Schools - New Jersey school certification.

Congratulations! If you aren't then you are prudently looking ahead into the FRS-NJ certification process and we commend you on your foresight, planning, and leadership.

Logistical Review

After submitting for Bronze Tier or Silver Tier school certification, the first action that is taken is called the Logistical Review. This review is performed by the FRS-NJ project coordinator upon receipt of your official certification submission to ensure that the submission is ready for review by the FRS-NJ Awards Committee.

As part of this process, we make sure that all of the information provided is what was required in the certification submission form, we perform a random click test to ensure that submission document links are viewable by anyone with the link, and we set your Indicator Tracking sheet to view only in order to ensure the integrity of the review and certification process.

Once the logistical review is completed, you are notified via email and the successful submission is announced via Twitter and Facebook. If updates are needed, those updates are requested via the official school contact provided upon submission.

Awards Review

Upon successful completion of the Logistical Review, submissions are sent to the Awards Committee for review and feedback. The Awards Committee is split

into the three FRS-NJ Themes and provides feedback on submissions at two levels.

The primary method of providing feedback is in the Indicator Tracking Sheet submission, which is provided directly in your tracking sheet based on each indicator's rubric. Members of the Awards Committee may ask you questions in the tracking sheet about parts of your submission for the purposes of clarification, or if other concerns or issues with the submission arise. Please pay regular attention to your tracking sheet to see if there are any such comments, questions, or concerns.

September 15th is our deadline for notifying you of your final certification status so that you can adequately prepare for the Awards Ceremony at NJSBA's Workshop 2019 (see page 3).

Silver Tier Certification and Silver District Distinction

In addition to the indicator review process, Silver Tier school certification and the Silver District Distinction have a heavy focus on community leadership. This is reviewed by the FRS-NJ chairs and co-chairs of the community leadership team separately from your indicator submission. This means that silver certification and distinction notifications will likely come later than many bronze certification notifications.

The Whole Point

All submitters should remember that regardless of your final certification status, it is the journey of self-reflection, self-assessment, inclusive collaboration, and growth as a school and district that are at the heart of this process!


2019 FRS-NJ Awards Ceremony at NJSBA's Workshop October 22nd, 2019
