Rolling Review and Certification will be Implemented for the 2019 Cycle

Future Ready Schools - New Jersey, starting this month, will be offering the opportunity for schools that submit prior to late June to receive their reviews, feedback, and certification status notification on a rolling basis.

The first meeting of the 2019 Awards Committee was held on April 1st at the New Jersey School Boards Association in Trenton and is now ready to review incoming certification submissions. The review process will continue until late August and final certification status notifications are due to be sent to submitting schools by September 15th.

Submitting early will enable the Awards Committee to review your submission, provide feedback, and submit it to FRS-NJ for final processing far quicker than if you were to submit around the submission deadline of June 30th. Once everything that is needed for final certification status notification is processed by the FRS-NJ team, we will notify the official school contact and announce if your school is certified. This will also provide more time ahead of future submission deadlines, starting with the 2020 certification cycle, for your school and district teams to process your feedback, and to begin taking action based on your certification experience and results.

Submission are final for the 2019 cycle. If you have any questions on specific indicators, please contact us so at frs-nj@njit.edu so that we may direct your questions to the proper community leaders. This option is open until late June, when the bulk of submissions come through and the awards review process will be in full swing.

Workshop 2019 Call for Proposals Due April 1st, Some Sessions will be Featured in the 2019 FRS-NJ

Call for Presentations at Workshop 2019

The Workshop 2019 call for proposals is now open, and the NJSBA is looking for engaging, creative and thoughtful submissions. Proposals should reflect the best practices in education across the state.

The theme for Workshop 2019, "Imagine. Create. Lead," will explore the limitless potential in New Jersey's public education system.

The Workshop will take place from Monday through Thursday, Oct. 21-24, 2019 at the Atlantic City Convention Center.

Please consider the following session guidelines when shaping a proposal. These criteria will influence the selection of sessions to be presented.

- What Workshop Attendees Want:
- Sessions with a greater depth of content
- Sessions that focus on best practices
- Sessions that provide tools that can be easily implemented
- Sessions designed to engage and educate
- Sessions with differentiated content for new and veteran school leaders
- Sessions showcasing cutting edge innovations in the education field

Presenters are encouraged to submit a proposal for the following training opportunities at Workshop 2019:

• Action Labs are 90-minute programs, limited to 48 attendees, which actively involve participants. The majority of the time must be devoted to hands-on tasks directed by the presenter(s). On the Program Proposal Form, please clearly describe the program, spell out the objectives, and include a general list of activities so that the selection committee will be able to assess how the participants will enrich their skills.

Group Sessions are 60-minute programs which allow presenters to provide information for up to 200 attendees. At least one quarter of the program should be devoted to guestions and answers. In designing the program, consider using any one of the following formats: single speaker, panel, debate, or some other program structure. If there is more than one presenter, include all of the required information for each individual on the completed Program Proposal Form. These training opportunities are limited to three presenters. Please clearly describe the program and spell out the objectives so that the selection committee will be able to assess how the attendees will benefit.

All Workshop program submissions will receive equal consideration. The deadline for receiving completed forms is Friday, April 5, 2019 by 5 p.m. Those submitting proposals will be notified of the Associations' decision by mid-June. FAQs About the 2019 FRS-NJ Certification Cycle

Where can I view the recorded video of the 2019 FRS-NJ Certification Summit?	The recording is available at frsnj.org/2019summit .
How do I get an editable copy of the Board Resolution or School Participation Letter?	After you open the document, click File > Make a Copy to generate a copy that you can sign and submit.
How do I get a copy of the 2019 Indicator Tracking Sheet?	<u>Use this form</u> to request a copy of the tracking sheet for your school's use and submission.
Do I have to re-submit for District Commitment and School Participation (Phase I & II)?	No, if you have been officially confirmed already, you are good to go!
How do I get an editable copy of each indicator's Submission Document?	The links provided in the Indicator Tracking Sheets are to the template Submission Documents. You'll need to make your own copy for each indicator that you intend to submit, and then replace the template link with your own. Make sure to set the permissions to "Anyone with the link can View."
The theme-based minimum points requirements don't add up to the total requirement, why?	Don't worry, this is intentional! This allows for some flexibility as to what indicators you submit outside of the minimum points requirements in each theme.


"Are You Ready for Future Ready?"
