2019 FRS-NJ Certification Summit on Feb. 28th

Information and registration for the 2019 Future Ready Schools - New Jersey Certification Summit is officially live!

Each year, the Certification Summit celebrates national <u>Digital Learning Day</u> (#DLDay) by launching the year's certification cycle and introducing program updates, developing initiatives, and showcasing how other schools and districts have successfully achieved certification from their perspective.

This year's summit will take place on February 28th and will feature three ways for New Jersey educators to attend. Option 1 is to attend the main event inperson at NJIT in Newark. Option 2 is to attend the satellite location hosted by the SRI&ETTC at Stockton University. For those who cannot attend live or inperson, Option 3 is to steam the event live from anywhere or to view the recording later on.

Updates on the 2019 Certification Cycle Since the January Issue of the FRS-NJ Monthly Newsletter

Important Updates on 2019 Certification Cycle

Over the last several months, the Future Ready Schools – New Jersey coalition (NJIT, NJDOE, & NJSBA) has been working to prepare the 2019 certification program, as well as a number of supporting initiatives, ahead of the launch of this year's certification cycle on February 28th.

In the January issue of the FRS-NJ Monthly Newsletter, we announced several of these initiatives would launch in the 2019 cycle, including the Gold Tier certification and the Professional Development initiative. Since the release of that newsletter issue, we have found that there are a number of factors that would render the 2019 release of the new certification tier, and other initiatives, incomplete and not to the standard we insist upon if released this year. Therefore, we have made the difficult decision to postpone the following initiatives until at least 2020:

- Gold Tier Certification
- Professional Development Initiative
- Small Grants Program

The additional time granted by this delay will enable the coalition to ensure that the guidance, support, and resources that FRS-NJ provides will be as effective and efficient as possible. However, in lieu of the 2019 Gold Tier certification, we are providing a bridge opportunity for those districts and districts who have achieved silver-level certification for all of their schools in the form of the Silver District Distinction.

Introducing the 2019 Silver District Distinction

Over the last three years, schools and districts across New Jersey have been breaking down silos to collaborate with and support each other through the Future Ready Schools - New Jersey certification program. As we continue to develop the coming Gold Tier district certification, we want to recognize those districts that have achieved Silver Tier certification in all of their schools and have proven themselves dedicated to sharing their success with, and supporting the Future Ready efforts of their peers statewide.

Thus, FRS-NJ is introducing the Silver District Distinction for the 2019 certification cycle to recognize the critical role that is played by certified schools and districts in sharing their success with the New Jersey educational community so that others may follow in their footsteps.

The requirements for this distinction will evolve into the Gold Tier Certification when it is launched and focuses on the district's leadership in the #FutureReadyNJ community, how the district disseminates its success across the state, and how the district celebrates those educators, leaders, and stakeholders that have made this success a possibility.

Full details on the requirements for this distinction will be announced at the February 28th FRS-NJ Certification Summit and will be available online at www.frsnj.org by that date.

For those districts that are currently eligible for this distinction, we invite you to contact us with any questions about the process and purpose of this distinction.



Army Educational Outreach Program's (AEOP) Research & Engineering Apprenticeship Program (REAP) at NJIT

The Research & Engineering Apprenticeship Program (REAP) at NJIT is commuter summer STEM program that places talented high school students from groups historically under-represented and underserved in STEM. Research apprenticeships take place at universities. REAP apprentices work on a hands-on research project, under the direct supervision of a mentor.

Dr. Kevin Belfield of the Department of Chemistry and Environmental Science at the New Jersey Institute of Technology (NJIT) in Newark, NJ is pleased to announce openings for a limited number of eligible high school students to pursue research in a 6-week program during summer 2019 in materials for biomedical

applications and imaging, organic chemistry, and biochemistry. In addition to hands-on experience in cutting-edge research, students will receive a stipend of \$1,500 and be part of a number of university-wide activities for participating summer high school student researchers at the institution.
